I hereby agree that in consideration of water being supplied to said premises, that I will be responsible to Garden City, for, and pay, a monthly assessment regardless of quantities used in said premises, whether on flat or metered service, whether supplied to myself, tenant, or another occupant.

I further agree to provide proper installation of cross-connection and backflow prevention devices for outside water, now and in the future, required by ordinance, in the state of Utah, or Town of Garden City, my own shut off valve (stop & waste), and to keep all taps and other fixtures, through which water may be obtained, in proper repair. Inspectors of the Town shall at all reasonable hours have their right to enter said premises and to make excavations thereon, for the purpose of inspecting meters, pipes or other appliances belonging to the town, or for disconnecting said premises or any part thereof for nonpayment of rates or for violations of this agreement.

**DISCLAIMER**

I agree to contact the Town of Garden City for a water meter as soon as building begins on a new construction. I further agree, I will not alter or tamper with the meter box, water line, or other Town owned or regulated property, and will follow all procedures and guidelines in accordance with Garden City Code 13A-102. I further agree that the water service may be turned off due to violation of the Garden City Ordinances and I will be assessed the appropriate penalties.

If balance of water bill is not paid in full by the due date, I hereby agree to pay interest in the amount of 18% per annum from the date issued on any portion that is unpaid. I also agree to pay collection agency fees not to exceed 50% of the total amount to be collected, plus all attorney's fees and court costs involved with collections.

**I accept full responsibility of this connection and account until it is transferred to another owner. I agree to start paying for monthly water service upon the completion of this application and payment of the connection.**
